2. On receipt of complaints, the Anti-Ragging Committee shall immediately enquire into the matter and take stubborn action against those who indulge in the ragging.
3. A complaint box shall be arranged in the college premises in the ground floor to enable the students to post their complaints to the Anti-Ragging Committee.
4. Anti Ragging posters shall be displayed in the notice board warning the students not to indulge in ragging.
5. Phone numbers of the members are to be displayed in the notice board.
6. An interaction programme between juniors and seniors shall be conducted with an aim to develop cordial relationship between juniors and seniors under the supervision of teaching faculty & HOD.

**What is Ragging?**  
Any Act Resulting in:

- Mental/physical/sexual Abuse
- Verbal Abuse
- Indecent Behaviour
- Criminal Intimidation/wrongful Restraint
- Undermining Human Dignity
- Financial Exploitation/extortion
- Use Of Force

**A STUDENT INDULGING IN RAGGING CAN BE:**

- Cancellation of admission.
- Suspension from attending classes.
- Withholding/withdrawing Scholarship/Fellowship and other benefits.
- Debarring from appearing in any test/examination or other evaluation process.
- Withholding results.
- Debarring from representing the institution in any regional, national or international meet, tournament or youth festival etc.
- Collective punishment: when the persons committing or abetting the crime of ragging are not identified the institution shall resort to collective punishment as a deterrent to ensure community pressure on potential ragger.
